Official Rules

NO PURCHASE NECESSARY TO ENTER. MAKING A PURCHASE WILL NOT INCREASE AN ENTRANT’S CHANCES OF WINNING.

The 2024 Snackworks Monthly Promotion (“Sweepstakes”) is sponsored by Mondelēz Global LLC (“Sponsor”), 100 Deforest Avenue, East Hanover, NJ 07936 and is administered by Twelve Thirty, LLC (“Administrator”).

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at or about 12:00 AM (midnight) Eastern Time (“ET”) on March 15, 2024 and ends at 11:59:59 PM ET on December 31, 2024 (“Sweepstakes Period”). The Sweepstakes is comprised of ten (10) entry periods (each, an “Entry Period”) as set forth in the chart below:

Non-winning entries submitted in an Entry Period **will not** carry forward to subsequent Entry Periods. The Administrator’s computer is the Sweepstakes’ official clock.

- 2. ELIGIBILITY:** This Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees, officers and directors of Sponsor, Administrator, HMT Associates, Inc. and any of their respective owners, parent companies, affiliates, directors, subsidiaries, representatives, advertising, promotion and production agencies or agents (collectively, the “Sweepstakes Entities”) as well as the immediate family members (defined as including spouse; biological, adoptive, and/or step-parents, grandparents, siblings, children and grandchildren, and each of their respective spouses, regardless of where they reside) and persons living in the same household (whether related or not) of any of the above are not eligible to enter or win. Void outside the 50 United States/the District of Columbia and where prohibited by law. All federal, state and local laws apply.

Participation constitutes entrant’s (and entrant’s parent’s or legal guardian’s if entrant is deemed a minor in the jurisdiction in which he/she resides [“Minor”]) full and unconditional agreement to these Official Rules and Sponsor and Administrator’s decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Sponsor or Administrator. For purposes of the Sweepstakes, an entrant’s residential address and e-mail address will be the

physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical address or e-mail address on a submitted registration. If it is discovered or suspected that an entrant has registered or attempted to register for the Sweepstakes more than once per calendar day using multiple e-mail addresses or multiple identities, all of that entrant's entries will be declared null and void and any prize that he/she might have been entitled to win will not be awarded and will be revoked. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any entrant attempting such use.

- 3. HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, eligible entrants must visit snackworks.com/monthlysweepstakes ("Website") and submit their valid e-mail address. If it is the entrant's first time participating in the Sweepstakes, the entrant must first complete and submit the registration form with all required information, which may include, but may not be limited to, first and complete last name (no initials), telephone number, street address (no P.O. Boxes will be allowed), city, state, ZIP Code, and date of birth. After registering or (submitting a valid e-mail address on subsequent days), the entrant will receive one (1) entry into the Sweepstakes.

LIMIT: Each entrant is limited to receiving one (1) entry per day during the Sweepstakes Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Sweepstakes Period. If more than one (1) entry per day is received from the same person, telephone number, address, or e-mail address, and no attempted fraud is suspected, only the first entry received may be considered valid. If fraud is suspected by the Sponsor or Administrator, the entrant will be disqualified and all of his/her entries will be declared null and void.

- 4. RANDOM DRAWINGS:** On or about each of the Random Drawing Dates set forth in the chart in Section 1, the Administrator will randomly select one (1) potential winner from all eligible entries received during the applicable Entry Period (each, a "Random Drawing"). Each winner is considered a potential winner pending verification of his/her eligibility and compliance with these Official Rules.

5. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:

a. Prizes (1 per Entry Period, 10 total): Each "Prize" is a Mondelēz gift basket, which consists of a variety of assorted Mondelēz products. The actual components of the gift basket will rotate each month based on availability and seasonality, and will be determined in the Sponsor's discretion. One (1) Prize will be awarded in each Entry Period, for a total of ten (10) total Prizes awarded in the entire Sweepstakes. The ARV of each Prize is \$125

b. Total ARV: The total ARV of all available Prizes in the Sweepstakes is \$1,250.

c. Odds of Winning: The odds of winning a Prize depend on the number of eligible entries received during the applicable Entry Period combined with all non-winning entries received in previous Entry Periods.

d. General Prize Conditions: There is a limit of one (1) Prize per entrant/person/household during the entire Sweepstakes Period. Details of Prizes will be determined by Sponsor in its sole discretion. All styles and sizes are determined by Sponsor in its sole discretion.

- 6. HOW TO CLAIM A PRIZE:** Potential winners are subject to verification of eligibility and compliance with these Official Rules. Each potential winner will be notified by e-mail with instructions on how to claim their Prize. All potential winners may be required to provide additional documentation for verification purposes within a specified time period. If a potential winner is disqualified, found to be ineligible or not in compliance with these Official Rules, fails to timely provide any requested additional documentation, or declines to accept a Prize, the Prize may be forfeited. If a Prize is forfeited for any reason, the Prize may be awarded to an alternate winner, selected in a random drawing from among all remaining non-winning entries received for the applicable Entry Period combined with all non-winning entries received in previous Entry Periods, as determined by Sponsor in its sole discretion. If, after three (3) attempts, Sponsor is unable to award or deliver a Prize for any reason, such Prize will be forfeited and will not be re-awarded. Prizes will be mailed to verified winners at the street address provided at the time of registration within approximately eight (8) to ten (10) weeks from the end of the applicable Entry Period, following verification of winners' eligibility. Each winner shall be solely responsible for payment of any and all applicable federal, state, and local taxes for any Prize won. Sponsor will attempt to notify each potential winner as set forth above, but Sponsor is not responsible for any undelivered e-mails, including without limitation e-mails that are not received because of a winner's privacy or spam filter settings which may divert any Sweepstakes email, including any winner notification email, to a spam or junk folder. Prizes that are unclaimed, unredeemed, or returned as undeliverable will not be awarded. The right to receive a Prize is non-assignable, non-transferable and no Prize substitution, exchange or cash equivalent will be allowed, except by Sponsor, who reserves the right to substitute a prize (or prize component) of equal or greater value in case of unavailability of a Prize (or Prize component) or the occurrence of a *force majeure* event, at Sponsor's sole and absolute discretion. Sweepstakes Entities shall not be held responsible for any delays in awarding any Prize for any reason.
- 7. The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any entrants, tampering, hacking or by any of the equipment or programming associated with or utilized in the Sweepstakes and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Website or any Sweepstakes-related website(s). incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE MAY NOT APPLY TO YOU.
